Regular Meeting

The Tilden Township Board of Supervisors met in the Township Municipal Building with the following present: Supervisors Gene Schappell, Russell Werley and Judy Romig, Township Secretary, Cheryl Haus, Township Solicitor, James Lillis and several citizens. A motion was made by Judy Romig and seconded by Russ Werley to authorize Kozloff Stoudt to finalize the amended Floodplain Ordinance, forward it to BCCD for approval, and prepare for adoption at the earliest date possible. Upon roll call, Romig, Werley and Schappell voted yes.

**RESOLUTION # 9, 2011**

Resolved that, Dennis Schwoyer, the term of his agreement for services as Chief of Police to expire on June 30, 2011, and his being a duly qualified Police Officer pursuant to the laws and regulations of the Commonwealth and Township, is hereby assigned to the position of fulltime Patrolman, effective July 1, 2011, at his present annual salary of \$48,079, together with all other benefits and privileges as set forth in the prevailing Collective Bargaining Agreement between the Township and the Tilden Township Police Association.

Upon roll call, Romig and Werley voted yes. Gene Schappell voted no.

A motion for Resolution # 10, 2011 was made by Russ Werley and seconded by Judy Romig

**RESOLUTION # 10, 2011**

Resolved to assign William McEllroy as Acting Police Chief, effective July 1, 2011, at his current salary, together with a stipend in the amount of \$1,500.00, for service as Acting Chief, through December 31, 2011, as well as continuation of all other benefits and privileges pursuant to the Collective Bargaining Agreement between the Township and the Tilden Township Police Association.

Upon roll call, Werley, Romig and Schappell voted yes.

Supervisor Gene Schappell thanked Chief Schwoyer for his years of service as Chief of Police, on behalf of the Township and residents.
