

RESOLUTION NO. 1, 2018

WHEREAS, Resolution # 1-2018, and Section 2004 of the Zoning Ordinance of Tilden Township, Ordinance No. 122, enacted July 2, 1998, as amended, provides that the Township Board of Supervisors shall establish, by resolution, a schedule of fees and charges for requests for zoning and/or building permits, certificates of use and occupancy, special exceptions, variances, Zoning Ordinance amendments, and all other matters pertaining to the Zoning Ordinance:

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Tilden Township, Berks County, Pennsylvania, that pursuant to the powers set forth in the Second Class Township Code, the Municipalities Planning Code, and the Tilden Township Zoning Ordinance, the current schedule of fees and charges for permits and requests for relief under the Tilden Township Zoning Ordinance is as follows:

- A. Appeal of Zoning Officer Action
(Township will return fee if appeal is granted) \$1,000.00
- B. Appeal of Validity of Zoning Ordinance or Map \$2,000.00
- C. Variances \$1,500.00
- D. Special Exception \$1,500.00

II. Hearings Before the Board of Supervisors

- A. Zoning Change \$2,000.00
- B. Curative Amendment \$2,000.00
- C. Conditional Use \$1,500.00



- C. Preliminary Opinion Request \$ 350.00






