

TILDEN TOWNSHIP BOARD OF SUPERVISORS

Friday, February 8, 2019
Workshop

The Tilden Township Board of Supervisors met in the Township Municipal Building with the following present: Supervisors Gene Schappell and Fred Herman; Absent: Richard DeLong, Road Master Mike Quick, Police Chief William McEllroy, Township Secretary/Treasurer Monica Flower, and local residents. The attendance roster is on file with the secretary.

The meeting was called to order by Chairman Gene Schappell at 9:04 a.m. followed by the Pledge of Allegiance.

Items discussed were:

Public participation:

- Mark Magrecki, PennTerra Engineering, presented plans of subdividing Bass Pro/Cabela's property (lots 4, 5 & 6). Mark also reported the hotel plans have been held up due to a transition phase within Hilton on a new prototype.
- Tami Berks inquired about the newsletter, which is in progress and almost finished.
- Susie Bigelow asked if the developer has filed an appeal. It was reported he has not as of yet. A discussion was held.

Police: Chief McEllroy

- The new vehicle is at Koch 33 and should be ready within the next two weeks.

Road Master: Michael Quick

- A couple storms came through and road crew did a great job.
- Dugout repairs have been started. Mortar work and roof will be done when it warms up.
- This year's Road project will be presented at the March meeting.
- The Berne Road project will be finished in the spring.
- The garage is in need of maintenance and is on the schedule for this year.

General discussion:

- CPR training for non-uniformed personnel and baseball coaches has been scheduled for March 26th, 5-7pm.
- The Environmental Advisory Committee members were reviewed and a discussion was held pertaining to the Sunshine Law. It was determined only one Supervisor should sit on this committee.
