

ORDINANCE NO. 109, 1996

AN ORDINANCE AMENDING ORDINANCE NO. 63 OF 1987, AS AMENDED, REGULATING TRAFFIC AND PARKING IN THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA, TO PROVIDE FOR SPEED LIMITS ON ASH ROAD, DOGWOOD ROAD, FOX ROAD, FOXWOOD DRIVE, AND ERIN WAY AND ELIMINATING A PROHIBITION AGAINST MAKING LEFT HAND TURNS SOUTHBOUND ON HILL DRIVE AT SCENIC DRIVE.

The Township of Tilden hereby ordains as follows:

Section 1. Ordinance No. 63 of 1987, as amended, is hereby further amended in pertinent parts as set forth herein:

ARTICLE II -- TRAFFIC REGULATIONS, Section 1(a) is hereby amended to read as follows:

(a) Maximum speed limits are established on portions of specific highways, as follows, and it shall be unlawful for any person to drive a vehicle on any part of a highway where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the highway:

<u>Highway</u>	<u>Between</u>	<u>Maximum Speed Limit</u>
Ash Road (T-697)	Intersection with Berne Road (T-811) and Hill Drive (T-805)	30 mph
Dogwood Road (T-693)	Intersection with Fox Road (T-566) and Salem church Road (S.R. 4023)	35 mph
Fox Road (T-566)	Intersection with St. Michael's Road (S.R. 4028) and Shartlesville Road (S.R. 4026)	35 mph
Foxwood Drive (T-567)	Entire length of Foxwood Drive including the cul-de-sac	25 MPH
Erin Way (T-568)	Intersection of Foxwood Drive (T-567) and Erin Way (T-568)	25 mph

ARTICLE II -- TRAFFIC REGULATIONS, Section 9 is hereby amended to read as follows:

Section 9. [Reserved]

Section 2. Severability.

The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal, or otherwise invalid, that decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is declared as a legislative intent that this Ordinance would have been enacted had that unconstitutional, illegal or otherwise invalid provision not been included in the Ordinance.

Section 3. Repeal of Certain Prior Ordinances.

All prior ordinances of the Township of Tilden, insofar as they deal with the regulation of traffic and/or parking, are repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this Ordinance.

Section 4. Effective Date.

This Ordinance shall take effect five (5) days after its enactment.


