

ORDINANCE NO. 131, 2000

AN ORDINANCE OF TILDEN TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, CHANGING THE NAME OF A PORTION OF LOWLAND ROAD (T-744) TO "INDUSTRIAL DRIVE" (T-571), AND DESIGNATING SUCH PORTION AS T-571; AND CHANGING THE NAME OF A PORTION OF KILN ROAD (T-803) TO "LOWLAND ROAD," AND DESIGNATING SUCH PORTION OF LOWLAND ROAD AS T-744.

BE IT ENACTED AND ORDAINED by the authority of the Board of Supervisors of Tilden Township, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. The following roads and streets will be re-designated as follows:

<u>Current Name</u>	<u>From</u>	<u>To</u>	<u>New Name</u>
Lowland Road (T-744)	West State Street (S.R. 4028)	Industrial Drive (T-571)	Industrial Drive (t-571)
Kiln Road (T-803)	Industrial Drive (T-571)	Lowland Drive (T-744)	Lowland Road (T-744)

Section 2. The addresses of properties abutting these streets, roads, and/or lanes shall include reference to the foregoing streets, roads, or lanes as applicable. Each such abutting property owner shall utilize the new street road or lane designation identifying his/her property.

Section 3. Any provision of any ordinance inconsistent with the provisions of this ordinance shall be repealed to the extent of the inconsistency. Any references to said roads, streets, or lanes in the Ordinance known as the "Tilden Township Traffic Ordinance," as amended, shall be deemed to be changed to reflect the names as designated above.

Section 4. This ordinance shall take effect on the earliest date after enactment allowed by law.


