ORDINANCE No. 223, 2016

AN ORDINANCE OF THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 198, 2009, WHICH AMENDED AND RESTATED IN ITS ENTIRETY PART 2, ENTITLED "TRAFFIC REGULATIONS," OF CHAPTER XIX, ENTITLED "MOTOR VEHICLES AND TRAFFIC" OF THE TOWNSHIP OF TILDEN CODE OF ORDINANCES: TO AMEND SECTION 203, ENTITLED "STOP INTERSECTIONS ESTABLISHED," SUBSECTION (a) TO ADD AS SUBPARAGRAPH 107 TO THE LIST OF STOP INTERSECTIONS FISHER DAM ROAD AT THE RAILROAD CROSSING, IN EAST AND WEST DIRECTIONS OF TRAVEL; TO AMEND SECTION 206, ENTITLED "U-TURNS PROHIBITED," SUBSECTION (a), TO PROHIBIT U-TURNS ON CABELA DRIVE AT THE INTERSECTION WITH WILDERNESS TRAIL, TRAVELING EAST; AND TO FURTHER AMEND SECTION 206 TO PROHIBIT U-TURNS ON CABELA DRIVE AT MOUNTAIN ROAD TRAVELING WEST; AND TO AMEND SECTION 301, ENTITLED "PARKING, STOPPING AND STANDING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS", TO PROHIBIT PARKING, STOPPING, AND STANDING ON WEST STATE STREET SOUTH BETWEEN HILL DRIVE AND OAK ALLEY; ON UNNAMED ROAD FROM ITS INTERSECTION WITH INDUSTRIAL DRIVE (T-571) TO THE TILDEN TOWNSHIP PUMPING STATION #1; FROM THE INTERSECTION OF HEX HIGHWAY AND PINE ROAD TO TILDEN TOWNSHIP PUMPING STATION #3, IN ALL DIRECTIONS; AND AT 125 WEST STATE STREET AT TILDEN TOWNSHIP PUMPING STATION #2, IN ALL DIRECTIONS

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Tilden, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. Ordinance No. 198, 2009, which amended and restated in its entirety Part 2, entitled "Traffic Regulations," of Chapter XIX, entitled "Motor Vehicles and Traffic" of the Township of Tilden Code of Ordinances, is hereby amended and restated as follows

(a) Section 203, entitled "Stop Intersections Established," subsection (a), is hereby amended to add as subparagraph (107) the following stop intersection:

	<u>Stop Street</u>	<u>Intersection or Through Street</u>	<u>Direction of Travel</u>
(107)	Fisher Dam Road	Railroad Crossing	East/West

(b) Section 206, entitled "U-Turns Prohibited," subsection (a), is hereby amended to set forth the following as intersections at which U-Turns are prohibited:

	<u>Street</u>	<u>Intersection</u>	<u>Direction of Travel</u>
(1)	Cabela Drive	Wilderness Trail	East
(2)	Cabela Drive	Mountain Road	West

(c) Section 301, entitled "Parking, Standing, and Stopping Prohibited," is hereby amended to set forth the following additional locations at which parking, standing, or stopping shall be prohibited at all times:

<u>Street</u>	<u>Side</u>	<u>Between</u>
West State Street	South	Intersection of West State Street and Hill Drive and Oak Alley
Unnamed Road	All	Intersection of Unnamed Road and Industrial Drive (T-571) to Tilden Township Pumping Station #1,
Hex Highway	All	Intersection of Hex Highway and Pine Road, and Tilden Township Pumping Station #3
125 West State Street	All	At Tilden Township Pumping Station #2

SECTION 2. All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

SECTION 3. This Ordinance shall become effective five (5) days from the date of enactment.

SECTION 4. The Code of Ordinances of the Township of Tilden , Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented and modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances of the Township of Tilden, Berks County, Pennsylvania, as amended, upon adoption.
