ORDINANCE NO. <u>212</u> 2012

AN ORDINANCE OF TILDEN TOWNSHIP, BERKS COUNTY, PENNSYLVANIA VESTING THE POWERS TO EQUIP, OPERATE, MAINTAIN, REGULATE AND STAFF PARKS, RECREATION AREAS, AND RECREATION FACILITIES OF THE TOWNSHIP IN THE TILDEN TOWNSHIP BOARD OF SUPERVISORS; RETAINING THE CURRENT TOWNSHIP PARK AND RECREATION BOARD AS AN ADVISORY BODY; AND REPEALING AND AMENDING PORTIONS OF ORDINANCE No. 41, 1978, TITLED "TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA, PARK AND RECREATION BOARD ORDINANCE."

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Tilden Township, Berks County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same, as follows:

<u>SECTION I.</u> Title. This ordinance shall be known and may be cited as the "Township of Tilden, Berks County, Pennsylvania, Park and Recreation Ordinance."

SECTION II. Powers and Duties of the Board of Supervisors and the Park and Recreation Board.

Ordinance No. 41, 1978, Section 2 shall be repealed and said Section shall be amended to read as follows:

- A. The following power and authority shall be vested in the Tilden Township Board of Supervisors:
 - 1. To equip, operate, regulate, and maintain parks, recreation areas and facilities of the Township and those owned and/or operated in whole or in part by the Township;
 - 2. To set employment qualifications and employment policies for park and recreation employees of the Township;

- 3. To select, employ, and discharge park and recreation employees.
- B. Subject to the approval of the Board of Supervisors of the Township of Tilden, Berks County, Pennsylvania, the Park and Recreation Board created by Ordinance No. 41, 1978, shall act as an advisory body on matters relating to parks and recreation in the Township. The Park and Recreation Board shall have the right to give advice and recommendations to the Board of Supervisors with respect to establishing standards, qualifications, and salary classifications of recreation personnel; and with respect to equipping, maintaining, operating, and regulating park and recreational facilities of the Township.
- C. The Park and Recreation Board of the Township of Tilden, Berks County, Pennsylvania, shall have the power to adopt rules and regulations for the conduct of its business.

<u>SECTION III.</u> <u>Remainder of Ordinance in Full Force and Effect.</u> The remaining provisions of Ordinance No. 41, 1978 shall remain in full force and effect.

SECTION IV. Invalidity of Portions of Ordinance. In the event that any provision, section, sentence, clause or part of this ordinance shall be held to be invalid, such invalidity shall not affect or impair any remaining provisions, section, sentence, clause or part of this ordinance, it being the intent of this Township that such remainder of this ordinance shall be and shall remain in full force and effect.

SECTION V. The Code of Ordinances of the Township of Tilden, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented and modified by this Ordinance. This Ordinance shall become a part of the code of Ordinances of the Township of Tilden, Berks County, Pennsylvania, as amended, upon adoption.

SECTION VI. This Ordinance shall become effective in accordance with the law.
