## ORDINANCE NO. 92, 1993

AN ORDINANCE AMENDING ORDINANCE NO. 63 OF 1987, AS AMENDED, REGULATING TRAFFIC AND PARKING IN THE TOWNSHIP OF TILDEN, BERKS COUNTY, PENNSYLVANIA, TO PROVIDE FOR A TURNING RESTRICTION FOR TRAFFIC PROCEEDING SOUTH ON HILL DRIVE AT THE SOUTHERN INTERSECTION OF SCENIC DRIVE (T-808) AND HILL DRIVE (T-805) IN THE TOWNSHIP.

The TOWNSHIP OF TILDEN hereby ordains as follows: Section 1.

Ordinance No. 63 of 1987, as amended, is hereby amended in pertinent parts as set forth herein:

ARTICLE II - TRAFFIC REGULATIONS, Section 9 is hereby established to read as follows:

Section 9. Turning at Certain Intersections Prohibited or Restricted.

(a) It shall be unlawful for the driver of any vehicle, of the type indicated, travelling upon the first-named street at any of the following intersections, in the direction(s) indicated in each case, to make a left turn and/or a right turn into the second-named street, as indicated, at any time when such a turn is prohibited by this section:

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

#### Section 2. Severability

The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal, or otherwise invalid, that decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is declared as a legislative intent that this Ordinance would have been enacted had that unconstitutional, illegal or otherwise invalid provision not been included in the Ordinance.

## Section 3. Repeal of Certain Prior Ordinances.

All prior ordinances of the Township of Tilden, insofar as they deal with the regulation of traffic and/or parking, are repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this Ordinance.

#### Section 4. Effective Date.

This ordinance shall take effect five (5) days after its enactment. ENACTED AND ORDAINED on this Durlday of Didrucary, 1993.
