REPORT - POLICE

The report for June, 2014 was given by Chief McEllroy. 95 incidents were handled, 1,303 miles were put on vehicles and 130 gallons of fuel were used. On June 20, 2014 "Train the Trainer" training will be done for the new county radio system. Testing will begin August 4 and police use, phase roll out will begin approximately November 2, 2014. Officers are working on thefts in the mobile home park and surrounding roads. All thefts are from unlocked vehicles

REPORT - SOLICITOR

A motion was made by Gene Schappell and seconded by Fred Herman to withdraw the appeal of 2007 of the Township of Tilden, etal. Vs. Zoning Hearing Board of the Township of Tilden, etal. Judge Spreicher has ordered that a rule to show cause be issued to the parties to show cause why the case should not be terminated for inactivity. As per the Township Solicitor, circumstances have been resolved and there is no purpose in pursuing the appeal. Upon roll call, Schappell, Herman and Spatz voted to withdraw the appeal.

REPORT - DRIVEWAY/ROADMASTER

The Report for June, 2014 was received.

A motion was made by Fred Herman and seconded by Carl Spatz to hire Nick Gehringer as a full-time employee of the Road Crew. Mr. Gehringer will start at an hourly wage of \$16.00 per hour with health benefits beginning July 14, 2014. There will be a 90 day probation period. After the 90 days an evaluation will be done by the Roadmaster and within 2 weeks a report will be given to the Board of Supervisors. Upon a satisfactory evaluation and completion of his CDL, the hourly wage will be increased to \$17.50 per hour. All other benefits will be per the current employee handbook. Upon roll call, Herman, Spatz and Schappell voted yes.

Supervisor Schappell made a recommendation that painting of slow with arrows be painted on Hill Drive to help with a speeding problem. The secretary will talk to the Engineer for advice on how to proceed.

REPORT-SECRETARY

The Secretary's report for June, 2014 was given. The secretary worked with the auditor to supply information needed to certify billing numbers to Hamburg Municipal Authority as per the current contract. On June 11, 2014 the secretary attended the Berks County Secretary's Association meeting. DIscussionwas on Property Improvement, given by the City of Reading Zoning Officer. July 1, 2014 sewer bills were printed and mailed. The secretary worked with Milestone Financial and Municipal Partners to get paperwork ready for the Non-Uniformed Pension Plan switch. Hopefully all will be switched over by August 1, 2014.
